2537 Apologies

2538 Declarations of Interest

There were no declarations of interest.

2539 Community Police Matters

There was no Police presence at the meeting, however the Clerk informed the Council that there was a PACT meeting arranged for tomorrow night at 6.30 pm at the School. He asked if any of the Councillors could try to attend. The Clerk went on to inform of a suspected incident at the School which resulted in the Police visiting the home of one of the Councils contractors. The contractor had been carrying out his contracted duties when a teacher at the School apparently misread the situation. The Clerk said that the School had since apologised verbally to the contractor for the misunderstanding. The Council said that this situation could happen to anyone who was passing through the Memorial Park and the School should issue a written apology.

2540 County Borough Councillors Report

C. B. Cll'r. Leanne Jones addressed the meeting with a comprehensive report on recent events which included the following; she reported that there had been an incident of anti-social behaviour with youths taunting an elderly resident. One child had been identified and an apology given with other children under suspicion and being investigated by the Police; She reported on a robbery at Clos Caegwenith with a suspicious person on a quadbike being investigated; She said that she had requested that the yellow lines at the junction between Henfaes Road and Wenallt Road be extended and this was being looked at by NPTCBC; Regarding yellow lines in Park Street, this was apparently down to the residents of Park Street to request but in the meantime, NPTCBC had promised to carry out a survey. Cllr. Mike Hughes reported that an ambulance had been called to attend a resident on the previous week which had resulted in the road being completely blocked off; She said that the Countryside Department were looking into the maintenance of our bridleways and some footpaths as soon as possible; Regarding the steps at Cysgodfa she was able to report that the residents of Parkside, have now taken their official complaint to the second stage but no solution had been found as yet; Cllr. Leanne then informed of several events which were due to take place over the next couple of months all of which would be in her Newsletter.

The Clerk said that he had sent a short report for the Tonna section in the Councillors Newsletter.

The Clerk was asked to try again and if no joy, try to quickly contact a new supplier and place an order as soon as possible by gaining verbal approval from the Councillors.
