3150 Police

The meeting was attended by Police Inspector Lindsey Sweeney whose main aim was to introduce herself to the Council. She gave a brief report of her history with the Police and then went on to explain the coverage of the policing of Neath and Tonna in particular. She explained that Tonna was comparatively quiet by comparison with other areas throughout the County Borough. She took various questions from the members which mainly concerned some incidences of youths on bicycles and possible drug taking. Inspector Sweeney assured the Council of her best attention at all times. The Chair thanked her for her attendance and she left the meeting.

#### 3151 County Borough Councillors Report

The County Borough Councillor reported on a variety of items and issues including the position with regards to the canal maintenance; she said that the Council was looking into the position with regards to the bollards at Tai Banc; She said that she was waiting for a response with regards to the Notice Boards and therefore it was decided to leave making a decision until the next meeting; with regard to the maintenance of the canal bridge at Brunel Woods she said that the Council had agreed to look at this but she had not received a report back yet; she also confirmed that St Anne's drive resurfacing was included in the work agreed for 2022. Also discussed was the difficult access to and from Wenallt Road due to parking problems. Also, the traffic calming conditions were questioned by the members as it was felt that they had been poorly installed.

#### 3154 Delegates Reports

The Chair gave a short report on the recent meeting of One Voice Wales which included preparations for the forthcoming elections and notice that One Voice Wales were bringing out a Good Councillors Handbook. Clir Colin Powell reported on the recent meeting of the Finance sub-committee. He referred to Payments to Councillors and attendance allowances which would be dealt with at the AGM. He also referred to the NALC salary awards agreed by the NJC. It had been recommended that these be agreed including the back pay so that they would be free of the levy being introduced on April 1st and he proposed that this be carried out. This was seconded by Clir Darren Harrison and approved by the members. Finally, he referred to the new Election Nomination Packs which allowed self nomination. If anyone had any difficulties, they should contact the Clerk who would obtain the necessary help. Upon completion it was recommended that they be given to the Clerk who would deliver to the Election Office at Port Talbot
