3273 County Borough Councillors Report

3276 Delegates Reports

The Chair reported that he had delivered a lovespoon to Mrs Jean Davies on the occasion of her 90<sup>th</sup> birthday on Sunday, 4<sup>th</sup> December. He said that Mrs Davies was delighted with the gift which now made a matching pair with her husband who had already received a 90<sup>th</sup> lovespoon from the Council.

Christmas Tree and lights

The Clerk was able to confirm that the lights had been turned on as usual on the Friday before Advent, however the Church had not organised any market or carol singing. There then followed a lengthy discussion regarding next year and the fact that the Council should set about taking over the Project for next year.

Regarding new Christmas lights proposed to be erected on the street lamp posts, the Clerk was asked to obtain prices for erection and also the purchase of lights so that discussion, purchase and organisation could be achieved well in time for Christmas 2023. Also, it was mentioned that the lights on the existing large tree had now become overgrown by the natural development of the tree. A price should be obtained for the repositioning of these lights.

It was requested that these items be included on the agenda for the next meeting.

Training

The Clerk said that he had received confirmation that a group training session could be organised for up to 20 people at a much better rate per person than for individuals. If we went along with this, we could then invite a few members of neighbouring councils if they wished to make up the short-fall. A suitable date can then be agreed at the next meeting. The Clerk would liaise with the Headteacher at Tonna School to organise the use of the school's facilities.

Memorial Park Lease

The Clerk said that in order to progress this further he had been asked to provide his passport to be copied and used by the solicitor.

Traffic Calming

Cllr Huw Bradley raised the issue of noise caused by traffic over the new Traffic Calming introduced at Dulais Fach Road. It was pointed out that this was a subject for passing on to the County Borough Councillor and the Clerk was asked to convey these concerns to her.
