3302 Apologies

3303 Declarations of Interest

There were no declarations of interest.

3304 Police

The was no police attendance at the meeting.

Cllr Huw Bradley requested that a complaint be made to the Police and the County Borough Councillor regarding the double parking that is starting to creep in to Tonna. He felt that if this isn't nipped in the bud it will eventually lead to the village being grid-locked.

3305 County Borough Councillors Report

The Clerk informed that he had received an email from the County Borough Councillor offering her apologies for her non-attendance and giving a short report on recent points raised by the Council.

She reported the following;

various potholes and drains were being inspected as we speak, she was still trying to find out information regarding the Tonna maps, she said that the river is being investigated, new dog bins and litter bins have been installed throughout the village where needed, fencing on the main road has again been reported and is being dealt with, the dangerous part that recently injured a dog has already been dealt with

2 broken benches have been replaced.

Cllr Huw Bradley wished it to be reported that the traffic calming measures in Dulais Fach Road had been wrongly and badly positioned. He asked if NPTCBC could look into this and re-arrange the locations.

Cllr Martyn Lyddon reported that he had attended a consultation which was conducted by Counterculture Partnership LLP regarding the Neath Port Talbot Cultural Strategy.
