Council Meeting held at Tonna Primary Community School, School Road, Tonna commencing at 7.00 pm, on Tuesday, 14th March, 2023.

3320 Apologies

3321 Declarations of Interest

There were no declarations of interest.

3322 Police

The meeting was attended by PCSO Chris Gardner who reported that there had been some instances of someone attempting to get into cars throughout the area. He said that some anti-social behaviour in the area earlier this year had now been dealt with and was very much under control at the present time. Otherwise, the area was generally quite quiet. The Chair thanked him for attending the meeting and he left to continue his beat.

3323 County Borough Councillors Report

There was no County Borough Councillors report.

3326 Delegates Reports

The Clerk spoke on behalf of the members to confirm that the majority of the members had attended Bespoke Code of Conduct training on 7th March, together with three members of the Clyne and Melincourt Community Council. Generally, it was felt that the course provided some very useful information to all of the members who attended.

The Clerk said that he and Cllr Colin Powell attended a meeting with a delegation from Tonna RFC. Cllr Powell declared a personal interest. It transpired that several local dog-walkers were using the Tonna RFC area in general but were not cleaning up after their dogs. This was causing a problem with "dog-mess" on the pitch which was obviously a health hazard not only to the senior teams but also to the children's teams who regularly used the pitch. The club had considered fencing but this was more expensive than they could afford, so they asked if TCC could possibly help. One of their suggestions was to build a fence of pig wire between the Memorial Gates and the club, a short distance which they hoped would direct people

in general around the pitch rather than across it. After discussion it was felt that a small fence as suggested would serve no useful purpose. It was then proposed by ClIr Huw Bradley that a more useful procedure would be to request NPTCBC to declare the whole park a dog control area. The Clerk will follow up on this suggestion.

3327 Notice Board

The Clerk informed the Council that the new board had been ordered with an expected delivery of week commencing 17th April.

The Clerk updated the Council on a number of items as follows.

He said that any drainage improvements higher up should naturally be beneficial to the Council's water problem lower down the hill.
