Council Meeting held at Tonna Primary Community School, School Road, Tonna commencing at 7.00 pm, on Tuesday, 14<sup>th</sup> November, 2023.

3435 Apologies

3436 Declarations of Interest

There were no declarations of interest

3437 Police

There was no Police presence at tonight's meeting.

3438 County Borough Councillors Report

There was no County Borough Councillors report.

The Clerk said that he had received a verbal complaint regarding a lorry which was parking on the grass verge at Neath Road. It had been reported that the verge had been badly churned up and should be reported to the County Borough Councillor to take forward to the proper department. There was also a complaint about the access to the new playground at Hunters Ridge. The Clerk will pass on both of these matters to the County Borough Councillor

3439 The minutes of the Ordinary Meeting held on 10th October, 2023 were accepted as a correct record.

3440 Matters Arising

There were no matters arising.

3441 Delegates Reports

The Chair reported that he, together with a few other members of the Council, had attended the Royal British Legion Remembrance Service on Sunday last at St Anne's Church, Tonna. He said that he had laid the Community Council, Wreath at the wall of remembrance at the end of the service.

The Clerk then read out a report from Cllr Mike Rowlands following his attendance at a Webinar dealing with Biodiversity Grants in which the Council may be interested. It was agreed that a separate meeting be held to take this forward with a view to completing an application by the due date at the end of the month.

## 3442 Water Memorial Park

The meeting was informed that there were still some jobs to be completed but the very bad weather had prevented this. It was hoped that these additional works could be completed by the next meeting.

## 3443 Councillor vacancy

Cllr. Bill Walters reported that Mr James Yeoman had declared an interest in joining the Council as a Community Councillor. Due to a family illness, Mr. Yeoman would not be available to take up any position until January. Following discussion, the meeting felt that this would be perfectly satisfactory. Given this information, Cllr Bill Walters proposed that Mr James Yeoman be selected as a coopted Community Councillor for Tonna. The proposal was seconded by Cllr. Paul Sambrook and approved by the members. The Clerk will write in due course to Mr Yeomans and invite him to attend the January meeting.

## 3444 Community Council Surgeries

Following discussion, the meeting decided that the proposed Council Surgeries should take place on a quarterly basis with the first taking place on the last Saturday in January from 11.00 am to midday. The Clerk will liaise with the Headteacher.

#### 3445 Allotments

The Clerk reported that he would be posting the new Allotment Rules during the next month together with the request for payment.

## 3446 Christmas Lights

The meeting discussed whether or not to carry out a tour of the village to select the best dressed Christmas house. A sub-committee was elected comprising the Chair, Cllr. Darren Harrison and Cllr's. Ms. Johanne Barnes and Mike Rowlands. It was decided that they will, at a date to be decided, tour the village to check the decorations and decide if there is one that could be considered as the best dressed house. If so, the Council will provide a gift voucher prize of £25.

Regarding the street decorations for next year, it was decided that a sub-committee will be elected to progress this matter for next year and beyond

any sign should be bi-lingual. The Clerk will comply.
