3513 <u>Declarations of Interest</u>

3514 Police

There was no Police presence at tonight's meeting.

3515 County Borough Councillors Report

There was no County Borough Councillors report however, the Clerk informed that in a recent telecon with Cllr Jones she said that the Police thought that they had found the person who had been prowling the village looking for access to property and vehicles etc. She also referred to a van blocking the pavement in Heol Caredig. The Clerk said that he had drawn her attention to the fence damage in St. Anne's Terrace / Henfaes Road which was potentially dangerous and the water issue. Using her contacts the CB Cllr promised to look into both issues.

- 3517 Matters Arising

There were no matters arising.

3518 Delegates Reports

Cllr Mike Rowlands reported that he had attended training on "Making Effective Grant Applications". He then gave a short report to the members.

3519 Training

The Clerk confirmed that he had managed to get 7 members of the neighbouring council, Clyne and Melincourt Community Council, to attend our recent Group Training session. He would be invoicing them proportionately when he receives the invoice from One Voice Wales.

3520 Water Memorial Park

Cllr Colin Powell reported that he, Cllr Mike Rowlands and the Clerk had met with the Land Drainage supervisor from NPTCBC together with representatives from Tonna RFC in an effort to find out further information regarding the source of the flooding water which was eventually badly affecting Tonna Primary Community Scholl, Tonna RFC and the Council. It transpired that there was not much that NPTCBC or Tonna could do. The Rugby club were in fact looking at making good and drain on the high side of the field which may affect future flow of the water. There was also another idea which was being investigated but only for future consideration. There was further discussion with particular refence to how the water was affecting the Memorial Playground. Cllr Stephen Roberts proposed that one of the diagonal drains that had been installed last year be filled in as he thought that would help matters however it was decided that the Clerk should try to find a Land Drainage expert to see if he thought he could help in the matter.

3521 Community Council Surgeries

The Clerk again confirmed that the next Community Council Surgery would be held on Saturday, 27th April. It was decided that this should not be posted on the web site until the Clerk had cleared it with the Headteacher to ascertain that this date was acceptable.

3522 Allotments

The Clerk reported that the final allotment tenant had now confirmed that he was unable to take up his lease this year. The next in line on the waiting list would be contacted asap
