3698 Playground Project

The Clerk reported that he together with Paul Hinder and Eloise Stanton from NPTCBC met with the HAGS Project Manager, James Gill on 4th February for a contract pre-start meeting. It was confirmed that Hags intended to commence work on site on Monday 24th February and were aiming for 4 to 6 weeks completion. It was agreed that Tonna would accept interim payments based upon site measure.

The contract would also be subject to a final inspection and also standard warranties so individual site inspections would not be required for the remainder of 2025.

The Clerk said that he had been approached by Dragon Play regarding the annual inspections and they had confirmed the fee for the coming year being £99 per quarterly inspection and £125 for the Annual. It was proposed by Clr Colin Powell that three quarterly and one annual inspection be booked for the Dan Y Bryn Playground. This was seconded by Cllr Bill Walters and approved by the members.

The Clerk also reported that during the past month it was discovered that the Bank Slide at Dan Y Bryn was damaged beyond repair and for safety reasons had to be removed. At the same time, it was discovered that the rope bridge had loose ends which needed to be tightened and made safe. This work had now been carried out by the Open Spaces contractor.
